4. First Aid

Exposure

6. Accidental Release Measures

Containment	If greater than 1000kg is stored, secondary containment is required. Emergency plans to manage any potential spills must be in place. Prevent spillage from spreading or entering soil, waterways or drains.
Emergency procedures	In the event of large spillage (>100kg) of the dry product alert the fire brigade to location and give brief description of hazard. Engineering Controls
