### 4. First Aid

#### General Information

## 8. Exposure Controls / Personal Protective Equipment

### Workplace Exposure Standards

A workplace exposure standard (WES) has not been established by WorkSafe NZ for this product. There is a general limit of 3mg/m<sup>3</sup> for respirable particulates and 10mg/m<sup>3</sup> for inhalable particulates when limits have not otherwise been established.

No ingredient present at concentrations > 0.1% is considered a reproductive or developmental toxicant or have any effects on or via lactation.

The respirable fraction of the dust of this product is considered to be a target organ toxicant, because of the presence of crystalline silica at greater than 1%. Crystalline silica triggers STOT RE cat 1 classification if it is in the form of a fine respirable dust in an occupational (chronic exposure) setting. This is due to the development of acute silicosis which can occur following exposure to extremely high levels of fine silica dust. Silicosis is a type of pneumoconiosis – a disease of the lung that causes inflammation, scar tissue, lesions and fibrosis in the lung (alveolar). Symptoms include shortness of breath, cough, fever, loss of appetite and cyanosis (bluish skin). Silicosis can occur following prolonged exposure (e.g., 10 years) to relatively high levels of fine crystalline silica dust.

Based on limited animal research, it is possible that repeated inhalation of cellulose fibre dust may lead to inflammation and scarring of the lung.
