4. First Aid

General Information

5. Firefighting Measures

6. Accidental Release Measures

Containment	If greater than 1000kg is stored, secondary containment and emergency plans to manage any potential spills must be in place. In all cases design storage to prevent discharge to storm water.
Emergency procedures	In the event of spillage alert the fire brigade to location and give brief description of hazard. Stop the source of the leak, if safe to do so. Wear protective equipment to prevent skin, eye and respiratory exposure. Clear area of any unprotected personnel. Contain using sand, earth or vermiculite. Do not use sawdust. Prevent by whatever means possible any spillage from entering drains, sewers, or water courses. (If this occurs contact your regional council immediately).

Engineering Controls

In industrial situations, it is expected that employee exposure to hazardous substances will be controlled to a level as far below the WES as practicable by applying the hierarchy of control required by the Health and Safety at Work Act (2015) and the Health and Safety at Work (General Risk and Workplace Management) Regulations 2016. Eyes

Protective gloves are recommended. Nitrile gloves are recommended. Protective gloves or suitably resistant material must comply with AS 2161. Replace frequently. Gloves should be checked for tears or holes before use. Protective clothing must comply with AS 2919, AS3765.1 or AS3765.2. PVC or rubber boots must comply with AS/NZS 2210.2 and selected and maintained in accordance with AS/NS2210.1.

Respiratory

To prevent irritation a well fitted dust mask should be used (this is not recommended when exposure is close to the WES). Use of a P2 dust mask or fine particulate half or full face respirator with an effective seal is recommended when airborne concentrations approach the WES (section 8). Fit testing and clear guidelines and training for use and maintenance of PPE are necessary.
