### 4. First Aid

#### General Information

#### Exposure

### 5. Firefighting Measures

**Fire and explosion hazards:** There are no specific risks for fire/explosion for this chemical. It is non-flammable.

**Suitable extinguishing substances:** Carbon dioxide, extinguishing powder or water jet. Fight larger fires with water jet or alcohol resistant foam.

### 6. Accidental Release Measures

**Containment** In all cases design storage to prevent discharge to storm water.

**Emergency procedures** If a significant spill occurs:  
Stop leak if safe/necessary; Isolate area. Collect spill – see below; Transfer to container for disposal. Dispose of according to guidelines below (Section 13).

**Clean-up method** Use absorbent (soil, sand or other inert material). Rags are not recommended for the clean-up of spills, as they may create fire or environmental hazard. Collect and seal in properly labelled containers or drums for disposal. If contamination of crops, sewers or waterways has occurred advise local emergency services.

**Disposal** Mop up and collect recoverable material into labelled containers for recycling or salvage. Recycle containers wherever possible. This material may be suitable for approved landfill. Dispose of only in accord with all regulations.

## 8. Exposure Controls / Personal Protective Equipment

### Engineering Controls

In industrial situations, it is expected that employee exposure to hazardous substances will be controlled to a level as far below the WES as practicable by applying the hierarchy of control required by the Health and Safety at Work Act (2015) and the Health and Safety at Work (General Risk and Workplace Management) Regulations 2016. Exposure can be reduced by process modification, use of local exhaust ventilation, capturing substances at the source, or other methods.
